In consideration of the acceptance of this contract by the School, the undersigned agree to pay, in accordance with the following terms and conditions, total tuition, including registration, for the above named child(ren) \$ \_\_\_\_\_. The registration fee is non-refundable. Parents or legal guardians should sign this agreement and return to Lee Academy by March 22, 2024, for all returning students. After March 22, 2024 the registration fee will be \$400.00 per child for returning students.

3. I (we) agree to pay the balance of tuition in the following manner (check one).

4. My signature below indicates my acceptance of the policies of the School Board and Administration; the procedures, policies, and regulations as set forth in the school handbook; and the financial terms set forth herein. I authorize the school to refrain from administering examinations to the above student(s) or issuing any of his/her report cards or permanent records to anyone including myself, until all charges have been paid in full and all school property returned.

5. As a patron of Lee Academy I consent to have my child/children participate in the drug/alcohol screening program. Further, I release Lee Academy from any liability whatsoever arising as a result of the drug/alcohol testing program.

6. I further agree that enrollment may be canceled by me upon receipt by the school of written notice to that effect prior to June 6, 2024, without penalty except forfeiture of the registration fee. If enrollment is canceled after June 6, 2024 parents, legal guardians, or persons in loco parentis are obligated to pay the tuition and fees for the full academic year, and no portion of such tuition and fees so paid or outstanding will be refunded or canceled. Exceptions may be granted by the School Board if a student and his/her family move out of the community, if a serious medical problem prevents the student from completing the school year, or for such other circumstances as deemed appropriate by the School Board. The fact that the school tuition and fees may be paid in two or more installments does not constitute a fractional contract.

7. Should events beyond the control of Lee Academy, including but not limited to, any fire, act of God, hurricane, tornado, flood, extreme inclement weather, explosion, war (including armed conflict), governmental action, act of terrorism, risk of infectious disease, epidemic, pandemic, shortage or disruption of necessary utilities (water, electricity, etc.), or any other event beyond Lee Academy's control, occur, Lee Academy has the discretion to close the school and/or modify its curriculum, schedules, length of school day, length of school year, and/or means of learning and teaching methods. The Parent's financial obligations under this contract remain in full force and effect. Should the school close, the school's duties and obligations under this contract shall be suspended immediately without notice until such time as the school, in its sole and reasonable discretion, may safely reopen. If the school cannot reopen due to a force majeure event under this paragraph the school is under no obligation to refund any portion of tuition paid.
